MINUTES OF September 24, 2018 BOARD MEETING CENTRAL TEXAS GROUNDWATER CONSERVATION DISTRICT

Notice is hereby given that the Board of Directors of the Central Texas Groundwater Conservation District ("District") will hold a Regular Board meeting and a Public Hearing on Monday, September 24, 2018 at 9:00 a.m. in the District office located at 225 S. Pierce Street, Suite 104, Burnet, Texas. The following items of business will be discussed, considered, and potentially acted upon by the Board of Directors: (see footnote 1)

President Felps established a quorum through a roll call of Directors; declared a quorum present; and called the Meeting to order at 9:00 a.m.

President Felps asked for public comment. There was no public comment.

President Felps then asked for consideration and/or action on Thomas Ridge Community Wells. General Manager Sodek informed the Board that he had recently learned from the Thomas Ridge Homeowners Association of two unregistered and unpermitted private wells in the District that are providing water to nine homes in the Thomas Ridge Community. He has contacted the current property owner of the land that the wells are located on to request that the wells be registered and permitted according to District Rules. Several Thomas Ridge property owners that are currently using water from these wells were present and allowed to make public comment on their concerns associated with their continued use of these wells. President Felps instructed General Manager Sodek to continue to work with the owner of the wells to bring them into compliance with District Rules.

President Felps then announced to the Board and public that the Board would move to agenda Item Number 4 and conduct a Public Hearing at 9:26 a.m. on the proposed Rule Amendments to the District Rules. He called the hearing to order and stated that the hearing was being recorded, that notice of the hearing was posted under the Open Meetings Act and notice of the hearing was published in the Highlander and Burnet Bulletin, that staff and legal counsel would be heard from, public comment would be taken, and that at the close of the hearing, the Board posted action item to adopt the amended Rules may or may not be done depending on the nature of the comments received. A brief recess of the hearing was called at 10:09 a.m. and the hearing was resumed at 10:10 a.m. The hearing was closed at 10:15 a.m.

President Felps then moved to Agenda Item Number Five 5 to consider and/or act on Proposed Amendments to the District Rules. He noted that the Board may adopt the amended rules as is or could make any changes suggested during public comment. He stated for the record that he would prefer

that all five Board Members be present before a vote was taken on adoption of the revised District Rules. Legal counsel and members of the Board discussed the process for taking action on adoption of the rules following the public hearing.

Kathy Griffis-Bailey moved to:

Declare the comment period and Public Hearing on proposed amendments to District Rules closed and to postpone action on proposed amendments to the District Rules to the next meeting of the Board. Second was by Steve Henderson.

Vote on the motion carried.

President Felps then asked for consideration and/or action on Minutes of the Regular Board Meeting held August 24, 2018.

Bill Luedecke moved to:

Approve the Minutes of the Regular Board Meeting held August 24, 2018.

Vote on the motion carried.

President Felps then asked for consideration and/or action on Expenditures for August 2018; Budget Line Item Adjustments; and Review of 2017-2018 Budget. General Manager Sodek reported that the following line item adjustments were made within a budget category to the Fiscal Year 2017-2018 Budget:

As the authority responsible for having the official ballot prepared, Election Officer, Donnita Coats, certified that the following candidates were unopposed for election to office for the election scheduled to be held on November 6, 2018.

President Felps then asked for consideration and/or action on Cancellation of the November 6, 2018 Election.

Steve Henderson moved to:

Cancel the November 6, 2018 Election that was ordered for the purpose of Electing Director, Precinct 2 and Director, Precinct 4 for the Central Texas Groundwater Conservation District.

President Felps then asked for consideration and/or action on TML Multistate IEBP Insurance ReRates. General Manager Sodek presented the Plan Year 2018-2019 ReRate Sheets from TML Multistate IEBP. General Manager Sodek informed the Board that health insurance rates had not changed from the previous plan year.

Steve Henderson moved to:

Approve the TML Multistate IEBP Insurance ReRates for Plan Year 2018-2019 as presented.

President Felps then asked for consideration and/or action on the Proposed FY 2018-2019 Budget. General Manager Sodek presented and reviewed a proposed FY 2018-2019 Budget that included increases to the Payroll Expenses line items and minor changes to balance the budget from the Proposed Budget that was presented at the previous Board Meeting.

Kathy Griffis-Bailey moved to:

Adopt the Proposed FY 2018-2019 Budget, as presented, as the FY 2018-2019 Budget of the District. Second was by Steve Henderson.

Vote on the motion carried.

President Felps then asked for consideration and/or action on a 2018 Proposed Tax Rate. General Manager Sodek informed the Board that both the requirements for publishing tax notices and the requirement for holding two public hearings for a Large Taxing Entity before a tax rate is adopted have been met. The two public hearings on the tax rate increase were held on September 7, 2018 and September 14, 2018.

Bill Felps moved to:

Approve a Minute Order adopting a Tax Rate for the Year 2018. Pursuant to Chapter 8810, Texas Special District Local Laws Code, the District hereby adopts a 2018 Tax Rate of 0.0080/\$100 value. THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

President Felps then asked for consideration and/or action on determination of the Drought Stage. General Manager Sodek reported that there had been a tremendous amount of rain in the county recently with some areas have a good deal more than others. Felps Springs and Turkey Feather Spring flows have risen but are still below average. He recommended staying at the current Drought Stage 2 – Moderate Drought at this time. No action was taken to change the current Drought Stage.
